Regular Meeting Minutes Board of Health Meeting November 15, 2018

The Hopedale Board of Health held a regular meeting on Thursday, November 15, 2018, at 6:00 p.m., in the Draper Room, Hopedale Town Hall, 78 Hopedale Street, Hopedale, MA. Those in attendance included: Walter Swift and Jason MacDonald. The meeting was not videotaped.

A. CALL TO ORDER

Mr. Swift called the meeting to order at 6:02 p.m., noting all members were present.

2. FY2020 Budget Discussion

Mr. Swift noted that Ms. Villa prepared several spreadsheets, which included an expenditure ledger, vendor payment tracking and a wage analysis. He noted that the Board will continue to work on gathering budget information in preparation for a meeting with the Finance Committee in January or February. Mr. Swift noted that when the previous full time health agent left, a large sum of money was removed from the Board of Health's budget and he

would like to see it returned to the Board's budget now that the department is up and running.
