Hopedale Park Commission August 19, 2021 Meeting Minutes 7:00 pm Remote Meeting via Zoom

The meeting was called to order by Chairman David Sprowl.

Mike Reynolds made a motion to approve the minutes of July 15, 2021, seconded by David Sprowl and all were in favor.

Announcements, correspondences and requests

- The board received a request from Apple Country Music Together to use the Town Park for music lessons. The board has reviewed their Park Usage Form and Mike Reynolds indicated all that needed to be finalized is the discussion around what fees would be assessed for this use. Mike made a motion to approve the request for Apple Country Music Together to use the Town Park, seconded by David Sprowl and all were in favor.
- The board addressed the email from a resident regarding the growth along the east side of the pond near the Little Red Shop and possible return of using the goats. This growth has been an issue in the past and much was cleared by using Go Go Goats. The board will reach out to this vendor and get availability and costs which will be reported back at the September meeting.
- Park Usage request was received from MRMC Auxiliary for outdoor meeting near the Bandstand for September 14, 2021 which was approved by a motion from Mike Reynolds, seconded by David Sprowl and all were in favor.
- Boy Scout Camp out and Flag Retirement Ceremony request for Town Park for September 18, 2021.- the board received this request and is a historic event held in Hopedale. The Fire Chief sent a letter as well approving this event. Mike Reynolds made a motion to approve, seconded by David Sprowl, all were in favor.
