 - Project #606303 – RUTLAND – BRIDGE REPLACEMENT, R-14-004, INTERVALE ROAD OVER EAST BRANCH OF WARE RIVER** reduce cost to \$2,174,958 to reflect a more refined estimate compared to conservative cost assumptions used during the scoping process. The current programmed cost is \$3,435,600.
 - Project #604468 – WEST BROOKFIELD – BRIDGE REPLACEMENT, W-19-008, WICKABOAG VALLEY ROAD OVER SUCKER BROOK** reduce cost to \$2,179,161 to reflect a more refined estimate compared to conservative cost assumptions used during the scoping process. The current programmed cost is \$2,798,400.

 - Project #606629-Change name from WORCESTER-BLACKSTONE VISITOR CENTER (PHASE II) to WORCESTER-BLACKSTONE VISITOR CENTER, INCLUDING PEDESTRIAN BRIDGE W-44-144 OVER THE MIDDLE RIVER (PHASE II).** Cost to remain the same.
 - Project #606207-SPENCER-REHABILITATION ON ROUTE 9 (MAIN ST)** increase cost (difference will come from statewide funding) from \$3,207,000 to \$3,363,183 to reflect latest cost estimates.

Project #608168-DOUGLAS-RESURFACING & RELATED WORK ON WEBSTER STREET (RTE 16) increase cost (difference will come from statewide funding) from \$1,750,000 to \$2,429,447 to reflect latest cost estimates.

Project # 604864 –WESTBOROUGH-INTERSECTION & SIGNAL IMPROVEMENTS AT RTE 9 & LYMAN ST-Increase cost (difference will come from statewide HSIP & CMAQ funding) from \$6,277,796 to \$8,039,483 to reflect latest cost estimate.
