BOARD OF SELECTMEN Regular Minutes May 7, 2018

Call to order 7:00 pm - Draper Room

Chairman Wesley called the meeting of the Board of Selectmen to order at 7:00 p.m. in the Draper Room at Town Hall.

E. New Business

Chair Wesley advised the first order of business would be discussion with member of the Finance Committee

1. Discussion with members of the Finance Committee – FY19 Budget
Members of the Finance Committee present were Chair Karla Hopkins, Colleen Strapponi and
Derek Piatt. Ms. Hopkins reviewed the FY 19 Budget numbers with members of the Board of
Selectmen and for the public stating the budget does not have any capital projects due to financial
constraints. Ms. Hopkins recommended meeting with the Capital Planning Committee to start
planning projects for FY 2021, when the Town will have paid down enough debt to add some
capital projects. Administrator Sette stated he reviewed the Capital Plan and met with
department heads, who expressed they have immediate needs that cannot wait until FY2021.
Administrator Sette recommends the Town take a 2.375-million-dollar bond, so the most priority
items in the Capital Plan can be started. Items include:

Administrator Sette further explained the equipment can take a year or more before it is built thus pushing bonds payments out to FY2021. The Town will still be able to pay off smaller debt items before the larger ones are added. Following further discussion, the Board of Selectmen agreed to explore this option. Ms. Hopkins advised that the Finance Committee has a meeting scheduled this week and will add this topic for further discussion. The Board of Selectmen invited the Finance Committee their meeting on May 21, to hopefully get unanimous support of both boards prior to the town meeting.

Administrator Sette noted the letter from Philip Shwachman's Attorney on the proposed Local Historic District saying he is not in favor of his properties being included in the local historic district. Administrator Sette advised Mr. Shwachman the Local Historic District Study Committee has removed their proposal from the ATM but may move their request to the STM in June or November. The LHDSC will being holding hearings on the proposed eight local historic districts. Mr. Sette noted the LHDSC would is requesting to give a 10 to 15 minutes presentation on their activities and proposal as well as, the school superintendent giving a brief statement on the school department activities, at the beginning of town meeting. The Board had no objections to either giving statements.
