Regular Minutes May 21, 2018

Call to order 7:00 pm - Draper Room

Chairman Wesley called the meeting of the Board of Selectmen to order at 7:00 p.m. in the Draper Room at Town Hall.

Present: Selectman Thomas Wesley, Selectman Louis Arcudi, Selectman Brian Keyes, Town Administrator Steven Sette, Executive Assistant Susan Brouwer, Robert Speroni, Building Department and Susan Ciaramicoli, LHDSC, Videographer Marcia Matthews.

Chairman Wesley began the meeting with the Pledge of Allegiance.

E. New Business

1. Robert Speroni Building Commissioner/Zoning Enforcement Officer – Building Department and Zoning Enforcement Updates

Mr. Speroni provided the Board with a Building Department spreadsheet showing a breakdown of the number of permits applied for, inspections, receipts, and inspector wages. Mr. Speroni noted the Building Department is looking at different permitting software that will link to the Assessor's database for more efficient processing of permits and property assessments.

On the Zoning Enforcement side, Mr. Speroni was asked about in-law apartments and how they are enforced once the property is sold, as the in-law apartment does not run with the property, they are issued as special and expire once the property is sold. Mr. Speroni replied there is no easy way to monitor these types of permits, unless there is an insurance loss or a permit pulled for another reason.

2. Suzan Ciaramicoli Chair of Local Historic District Study Committee - Discussion on Historic Districts

Suzan Ciaramicoli Chair of Local Historic District Study Committee updated the Board on the LHDSC activities, including a public hearing that was held on May 15. The LHDSC is recommending (8) local historic districts including; 1) The Little Red Shop, 2) Harmony Hall Green Store currently known as Community Bible Chapel, 3) Draper Corporation Headquarters currently known as Atria Draper Place, 4) 107 properties in Bancroft Park, 5) Seven Sisters known as 109-135 Freedom Street, 6) Hopedale Center properties include Bancroft Memorial Library, Hopedale Unitarian Parish, Harrison Block, Hopedale Police Station, Hopedale Town Hall, Municipal Parking Lot, General Draper High School, Hopedale Community House and the George Albert Draper Gym, 7) Lake Point – Draper Mill, worker housing, Draper Ball Park and parking lot, and 8) the Hopedale Pond and Parklands.

Board members noted they received a letter from the Draper Mill owner requesting his properties be removed from the Local Historic District. The owner stated having any of the properties included would be a deterrent to getting a buyer for the mill. Board members shared concerns of private properties being included in Local Historic Districts saying they prefer the committee focus to be on Town-owned properties. By consensus, the Board supported not having the Draper Mill included as part of LHD, noting it limits the number suitors to buy and develop it. In addition, the Town recently rezoned properties to try and bring more tax dollars into the community, and this may have unintended consequences.

The Board thanked the LHDSC for their work and asked they go back and revisit their plan. The Board encouraged the LHDSC to remove private properties from the plan and only include town-owned properties. Ms. Ciaramicoli advised the committee will be meeting this week and she will bring the BOS recommendation to them.

F. Old Business

1) Continue Discussion with Finance Committee on FY19 Budget
Finance Committee Chair Karla Hopkins and member Mr. Hockenbury were present. Ms.
Hopkins gave an update on the FY19 budget stating that even with the Town managing budget
growth, it has exceeded the levy limit. Ms. Hopkins noted the Town has three options; 1) to
pass over the budget at tomorrow night's Annual Town Meeting 2) present an operational
override, or 3) go for a debt exclusion. An override or debt exclusion will need a separate
ballot vote.

The Board of Selectmen and Finance Committee reviewed options and decided to pass over the budget at tomorrow night's ATM placing budget articles on the June 19 STM warrant. The Boards will continue budget discussions and look for options. The Boards agreed continue discussion to the June 4 Selectmen meeting. This will allow both Boards time to review options and present a well thought out budget for the voters at the June 19 STM.
