4. <u>Letter from Zoning Board of Appeals - Request to increase fees and policy change on notification of abutters</u>

The Board received a letter from ZBA Chair Steve Gallagher advising the ZBA will be changing the process for notifying abutters. The ZBA had a policy where the applicant would notify the abutters via certified mail. Beginning in January 2018, the ZBA secretary will notify all abutters by regular mail to ensure the process is done within the legal requirements. The change in procedure will increase expenses and therefore the ZBA is requesting special permit and variance application fees be increased from \$275.00 to \$375.00.
