BOARD OF SELECTMEN Regular Minutes February 20, 2018

Call to order 7:00 pm - Draper Room

Chairman Wesley called the meeting of the Board of Selectmen to order at 7:00 p.m. in the Draper Room at Town Hall.

1. Appointment of Jim Abbruzzese to the Urban Renewal Committee

Town as good as it can possibly be. Mr. Abbruzzese said he currently serves as a member of

D. New Business

1. Downtown Revitalization Project update

Administrator Sette advised that CMRPC awarded a 62K grant for the overlay district. This in combination with the money allocated at the ATM will allow the Town to begin planning for the downtown revitalization. Administrator Sette stated plans for the downtown revitalization include utilizing the railroad, areas behind Town Hall and areas facing Hopedale Street and Freedom Street. Administrator Sette and Chair Wesley met with Secretary Ashe from the Department of Housing and Community Development who suggested the Town either partner with the local Housing Authority to form an urban renewal subcommittee or hold a general election to elect a redevelopment board. The Board of Selectmen requested Administrator Sette reach out to the Housing Authority to see if they may be interested in working on an urban renewal plan.

2. Update and formation of Urban Renewal Committee

Administrator Sette and Selectman Wesley met with the Housing Authority this past week to see if they were receptive to forming an ad hoc committee to look at an urban renewal project. Members of the Housing Authority were very receptive and voted to appoint Jason MacDonald Chair of the Urban Renewal Ad Hoc Committee.
