- 4. Appointment to Hopedale Board of Health Administrator Sette stated the board received a letter from Mary Arcudi requesting appointment to the Board of Health. Mr. Sette said in addition, he received an email from Board of Health Chair Walter Swift advising the BOH accepted the resignation of Lou Arcudi and unanimously supports Mrs. Arcudi's appointment to the Board of Health. Administrator Sette recommends the BOS vote to support the BOH nomination and ratify the appointment at the next meeting on June 28, 2016. There were no objections by the BOS.

MSDV to appoint Mary Arcudi to the Board of Health to fill the vacancy left by Lou Arcudi. Term will be until the next election.

#### E. New Business

National Park Presentation - Local Historic District
 Jennifer Smith from the Blackstone River Valley National Historical Park (BRVNHP) gave a
 presentation to board on the scope of the newly established national park, which includes the
 Town of Hopedale. Ms. Smith's presentation outlined steps to help the town establish a local
 historic district. The steps include; gathering local support, working with local historic
 commission and forming ad-hoc study committee.

Discussion of BOS following the presentation: Selectman Wesley inquired as to the budget amount and what the historic benefits would be to the town. Ms. Smith replied the total budget for the BRVNHP is about \$900,000 which is split with the Blackstone National Heritage Corridor. The benefit to the town is that properties that fall within the district would have encumbered ordinances placed upon them requiring business and homeowners to seek local approval prior to any exterior improvements being done to the property. Ms. Smith gave an example of an advantage stating that anyone moving into the established historic district area would have the protection in knowing that there are regulations/ordinances governing the neighboring properties which will require owners to maintain or retain historic appearance of their properties. Selectman Wesley then asked what resources would be available to property owners. Ms. Smith advised the National Park Service (NPS) would provide plans or studies but they are unable to provide financial support as that would come from Mass Historic Commission (MHC). Ms. Smith said the BRVNHP is asking the town to support the establishment of a Local Historic District.

Suzan Ciaramicoli advised the local historic commission has a renewed interest in forming a local historic district study committee because of the national park designation, which will further allow them to carry out the Park's mission. The areas of town that the local Historical Commission is considering designating as part of the local historic district include; the Parklands, the Town Park, the Little Red Shop Museum, the Draper Building and areas of Hopedale Street including the Unitarian Church. Additionally, Ms. Ciaramicoli advised that the local Historical Commission needs to get educated in order to learn more about the requirements to get a proper message out, so that residents understand what the impact would be to Hopedale. Other concerns of board members were; whether ordinances could be changed within the local historic district, and a list of challenges that other local historic districts faced as part of their process. Ms. Smith responded that ordinances do require a process but can be in fact changed and then recommended the town have other local historic districts come and share their challenges and experiences. In addition, Ms. Smith recommended having the Town or Historical Commission invite Chris Skelly from Mass Historic Commission to come and speak to the Town. Ms. Smith said that Mr. Skelly has years of experience and can provide a lot of knowledge and information on forming a local historic district.

Chairman Burns asked Sue Ciaramicoli who should appoint the ad-hoc? Ms. Ciaramicoli advised that the Historical Commission would consult with and provide recommendations to the BOS and community on the formation of the ad-hoc committee. Sue also advised there is a tool-kit that recommends what types individuals should be included on the committee.

Administrator Sette recommend an item be placed on the next BOS agenda to form and consider a charge for the Local Historic District Committee. Selectman Arcudi ask what is the Hopedale Historic Commission's actionable item for the next BOS meeting. Mr. Sette recommends the Historical Commission come up with the number of people and types of people they recommend to be on the committee and have the first steps complete before the BOS does anything else. Selectman Wesley sought a recommendation for a motion and Mr. Sette advised that no motion is necessary for tonight rather the historic commission be tasked with providing recommendations for the local historic district ad-hoc committee make-up. The BOS thanked Ms. Smith for her presentation and Ms. Ciaramicoli for bringing this forward.

  Administrator Sette referred to Chief Daige memo requesting the board abate \$34,144.52 of uncollectible ambulance receipts. After a discussion, the Selectmen recommended the accounts be turned over to a collection agency or attorney.
