- 4. Chairman Wesley is looking to have the Community Compact discussion on a future agenda.
- 5. Chairman Wesley would also like to invite the School Superintendent to a future meeting.

Administrator News

1. Update on the Freedom Street Bridge

Town Administrator Sette stated either Wednesday or Thursday the paving will be done and Friday everything will be taken off the bridge and the road will be reopened. Steve thanked the residents for the patience while the work was being done.
