# 1. Request to hold the 8th Annual Larry Olsen Summer Classic 10K Race, September 30, 2017 at 10:00 AM

Town Administrator Sette stated this is an annual race and gave an overview of the race route advising the race has water stops and is mostly goes through the Parklands. In addition, he mentioned there were no other events scheduled that day. The Park Commissioners and the Police have already approved the race; the Fire Chief was also notified, he did not share any concerns with the event.

2. Review and sign May 23, 2017 Annual Town Meeting Warrant

The Board reviewed the May 23, 2017 Annual Town Meeting Warrant. Administrator Sette provided an overview and explanation on the warrant articles.

Selectman Arcudi asked questions on the following warrant articles; Article 2 – Selectman Arcudi asked if there were any increases to the I line items and whether it is appropriate for the Town Clerk's salary to be under this line item. Administrator explained the article is for elected and appointed positions, which the Town Clerk position is an elected position. The only increase was the Town Clerk's salary advising the Town Clerk presented her budget, which included a salary increase to the Finance Committee, and the FinComm approved it. This will be presented to the voters at Town Meeting. Article 4 and Article 10 – Selectman Arcudi asked if these articles are based on receipts. Administrator Sette confirmed they are.

Administrator Sette explained Article 22 – authorizes the Board of Selectmen to discussion with an owner of a Solar Farm a PILOT agreement, which is Payment in Lieu of Taxes.

Selectman Wesley explained Article 28 – stating he requested this article be placed on the warrant for a Downtown Study to look at the Draper Reuse, downtown area including the Town Hall and parking.

### J. Requests for Future Agenda Items

Discussion occurred on placing a warrant article on the Fall Town Meeting to amend the Town Bylaws changing the dates of the Annual Town Election and Annual Town Meeting. Administrator Sette provided an explanation stating the election and annual town meeting should be changed due to school activities occurring the same week that Town Meeting should fall. Selectman Arcudi agreed stating he would like Town Meeting to occur prior to the election in order for members currently serving to be able to defend their articles on the town meeting floor. Administrator Sette cautioned state budget numbers might not be known if the annual town meeting is held too early.

# K. Administrator News

- 1) Administrator Sette reminded the residents of the upcoming May 23 Annual Town Meeting; reminding the Board of the 6:30 p.m. meeting prior to town meeting.
- 2) The Memorial Day celebration will be held on Monday, May 29. In case of inclement weather, Steve has arranged to hold the event inside the HS auditorium. He will let Board members know by Sunday.
- 3) Mr. Sette mentioned that Cumberland Farms is looking for the hours of operation to be 5 am to 12 am. Administrator Sette said that Cumberland Farms needs a Common Victualler License issued by the BOS and the license will determine the hours that food and beverages can be sold. Selectman Keyes stated they are planning on a September opening.
