Regular Meeting Minutes Board of Health Meeting December 21, 2017

The Hopedale Board of Health held its regular meeting on Thursday, December 21, 2017, at 6:00 p.m., in the Draper Room, Hopedale Town Hall, 78 Hopedale Street, Hopedale, MA. Those in attendance included: Chairman Robert Burns and Jason MacDonald. The meeting was videotaped.

A. CALL TO ORDER

Chairman Burns called the meeting to order at 6:02 p.m., noting that Walter Swift was absent. Mr. Burns welcomed Jason MacDonald as the new member of the board.

D. REPORT OF THE CHAIR

Mr. Burns reported that the recycle center is not open due to a problem with the bridge at the entrance. The board is currently planning an alternate route into the center, which will most likely be via Route 16. As soon as the recycle center is re-opened, a notice will be placed on the website.

1. Adoption of Regulations Governing the Practice of Bodywork

After discussion, it was moved by Mr. MacDonald, seconded by Mr. Burns, to adopt the Regulations Governing the Practice of Bodywork, and set the effective date of these regulations January 1, 2018. All voted in favor.

2. Set Permit Fee for Bodyworks Establishment

After discussion, it was moved by Mr. MacDonald, seconded by Mr. Burns, to set the permit fee for a bodyworks establishment at two hundred dollars (\$200.00) annually. All voted in favor.

3. Set Permit Fee for Bodyworks Therapist

After discussion, it was moved by Mr. MacDonald, seconded by Mr. Burns, to set the permit fee for a bodyworks therapist at seventy-five dollars (\$75.00) annually. All voted in favor.

4. Vote Massage Therapy Regulations Obsolete

Mr. Burns noted these regulations are now obsolete, as the state regulates and issues massage therapy permits.

It was moved by Mr. MacDonald, seconded by Mr. Burns, to vote the massage therapy regulations obsolete. All voted in favor.
