Board of Health Meeting Regular Meeting Minutes June 16, 2022

The Hopedale Board of Health held a regular meeting on Thursday, June 16, 2022, at 6:00 p.m., in the Draper Room, Town Hall, 78 Hopedale Street, Hopedale, MA. Those in attendance included: Walter Swift, Jason MacDonald and Mary Watson. Health Agent Bill Fisher was also present. The meeting was videotaped.

A. CALL TO ORDER

Mr. Swift called the meeting to order at 6:00 p.m., noting that all members were present.

B. PUBLIC COMMENTS

Scott and Jennifer Heim of 167 South Main Street had questions regarding an old septic system and the possibility of hooking up to Milford sewer.

F. DISCUSSION ITEMS

1. Regional Animal Control Governance Committee

It was noted that Hopedale needed to appoint a representative to serve on the Regional Animal Control Governance Committee. After a brief discussion, the board selected Health Agent Bill Fisher to serve on the committee.

2. Hopedale Ridge/Overdale Parkway Project

Mr. Swift/Bill Fisher briefly reviewed the water department's concerns regarding sewer and septic related to this project. Mr. Lima presented a letter to the board from his engineer, Mark Allen, regarding the ten lots. Mr. Lima asked question regarding deep hole and percolation testing.

3. Overflow Trash Bag Contractors

Mr. Fisher reviewed the data on trash bag contractors for bags which would be used for overflow trash. After a brief discussion, it was the consensus of the board to select the company Waste Zero to supply the overflow bags and have Mr. Fisher follow up with all details.

4. Other -

Mr. Swift discussed the issue of a site plan for a warehouse and distribution facility at 75 Plain Street, the old Rosenfeld Concrete location. He noted that this location fall within a groundwater protection district. He further noted that the board had not received any plans for review and no representatives of the property development have come before the board. After a brief discussion, it was the consensus of the board to send a letter to the Planning Board on this issue.

G. ACTION ITEMS

1. E.L. Harvey New Contract

Mr. Swift noted that the new contract with E.L. Harvey had some minor revisions to be made. It was the consensus of the board not to sign the contract until corrections have been made.

2. Salmon VNA & Hospice FY2023 Contract

Mr. Fisher reviewed the differences between the two proposed Salmon VNA & Hospice contract for FY2023.

After discussion, it was moved by Mr. MacDonald, seconded by Ms. Watson, to approve the FY2023 Salmon VNA & Hospice contract in the amount of \$2,000, and authorize the chair to execute the document. All voted in favor.

3. New Recycle Center Employee Application

Mr. Swift noted that because of some health issues of recycle center employees and scheduling problems, it was necessary to add another recycle center employee at this time. He also noted that because this was considered an emergency situation, the board did not post for the position. The board members reviewed the application and resume of candidate Lucas Bache.

After a brief discussion, it was moved by Mr. MacDonald, seconded by Ms. Watson, to appoint Lucas Bache as a recycle center employee with a start date effective as soon as all his paperwork is completed for the payroll department. All voted in favor.
