Mr. Swift noted that the town administrator was recommending the town raise and appropriate an additional \$32,520 for the FY23 budget to be added to the Board of Health's Other Property Related Services (a.k.a. Trash/Recycling) at the Special Town Meeting to cover an estimated shortfall.
