- Regional Animal Control has reported a \$20,000 surplus in grant funds and has asked participating towns if they wish to receive a percentage of the surplus or have it deposited in a capital account for the future purchase of a vehicle.

It was moved by Mr. Swift, seconded by Ms. Watson, to have Hopedale's percentage of the \$20,000 surplus in grant funds deposited in a capital account for the future purchase of a vehicle. All voted in favor.
