Mr. MacDonald reported that he will be at the recycle center every Wednesday from 5:30 p.m. to 6:30 p.m. and weekends by appointment only. He noted leaves and grass is free; there are charges for brush; he is getting a metal dumpster and wood dumpster shortly at no cost to the town.

#### F. REPORT OF HEALTH AGENT

Mr. Fisher reported:

- COVID-19 cases are on the rise in the state and a new booster is scheduled to be available in late September or early October.
- There is an uptick in tick borne diseases statewide.
- Sanitation issues at the Lucky Dog Kennel have been resolved and the animal control officer is monitoring other offenses.

- Air quality tests were performed throughout Town Hall and no issues were reported
- Green Mountain Cannabis will be a manufacturing and wholesale company and he sees no issues related to the board of health.
- The town will shortly receive Narcan kits.

Engineer David Sadowsky gave a brief review of the plan. Mr. Fisher read notes on the pros and cons of the drip dispersal system and the stone and pipe system.

After discussion, it was moved by Ms. Watson, seconded by Mr. Swift, to approve the disposal works/septic system plan for 270 South Main Street, with a requesting a variance, as allowed in 310 CMR 15.404, to reduce the required setback of the subsurface disposal system to the property (street) line from 10 feet, as noted in 310 CMR 15.405(a), to 5 feet.

All voted in favor.

After discussion, it was moved by Ms. Watson, seconded by Mr. Swift, to approve the disposal works/septic system plan for 272 South Main Street. All voted in favor.
