1. Set Recycle Center Annual Fee Schedule

The board members reviewed the current fee schedule for the recycle center.

After discussion, it was moved by Mr. Howes, seconded by Mr. MacDonald, to set the recycle center fee schedule for FY2020 at the same rates as the current fee schedule. All voted in favor.

The board also discussed the whether or not to order recycle center vehicle stickers for the 2019-2020 period. Since there were still stickers available, it was the consensus of the board not to order stickers and have the attendants mark the remaining 2018-2019 stickers with a magic marker.

Mr. MacDonald noted that the appointment of the inspector of animals is done annually.

After a brief discussion, it was moved by Mr. Howes, seconded by Mr. MacDonald, to appoint Kevin Sullivan as the Inspector of Animals. All voted in favor.
