Fr. Mac Murray appointed Chairman of Recreational Field committee

Charter states committee will work together to develop ideas and plans for open land in Hopedale including former landfill on Freedom St.

Committee will present its findings in 3 months.

There are five land parcels that are currently under consideration for fields use:

- 1. Harmony Field (Lot A)
- 2. Phillips Field (Mellen)
- 3. Draper Field (grass to landfill is owned by Hopedale. Asphalt in parking lot not owned by Hopedale)
- 4. Town Park
- 5. Moore Road/Lapworth parcel

Don Howes: offered up many documents concerning lands usage and parks opportunities

Mike Bresciani- need maps and ideas of land. Surveys, wetlands, etc.

Youth leagues should develop a wish list

How do we gain input from the rest of the town (outside youth and HS sports) to determine their needs and wants for recreational fields

Howes: Dog parks will pay for themselves with grants

Brian Keyes: Urban Renewal will have a public hearing on potential new developments

Brescani: Let's focus on what we own, maps

- Turf field on landfill no good, ground is too volatile
- Need maps and topography
- Feasibility Study looking at plan as a whole or a field at a time

Guglielmi: Draper Field is a priority for Urban Renewal

• Keyes: potential of urban renewal increasing tax base quickly
