SURVEY UPDATE

- Survey results haven't changed much, responses are still trickling in with 1-2 per day
- To date, the administrator has received 235 survey responses
- The survey will be in the Hopedale newspaper on Feb 1 to reach any residents that don't have access to the electronic version
- Low impact options were attractive to some, such as shuffleboard
- Dog Park low favorability
- Fishing, boating also low favorability
- End of February deadline for survey responses

Feasibility Study Contractor Discussion

- Mike Bresciani Either company would be a good choice. CDM Smith wealth of experience specifically with parcels of land that have problems, including Draper. But, both companies are quality. CDM (fixed price, take charge when things go wrong)
- Dave Guglielmi Both hit the mark for checks and balances. CDM hits all the right buttons for conservation committee
- Brian Keyes Gayle (big hypothetical possibly not realistic), CDM positive history. A toss. But leaning towards CDM.
- Jim Abbruzzese Likes CDM experience with Draper cap, etc. Gale doesn't have inclusive service like CDM, but their presentation is forward thinking. He chooses Gale (forward thinking, outside the box thinking)

- Jen McKeon Thinks both presented well. But, very different. CDM conservative. Gale –
 more impressive, out of the box thinking. Looked to Mike and Dave to offer input as to whether
 CDM could rise to include forward thinking of GALE with their conservative ways. Mike gave an
 example about Milford field. She thinks both would be good, but given this response, chooses
 CDM.
- Keith Smith Go with CDM. Familiarity with parcels of land and their limitations. Safer. Smarter.
- Derek Atherton CDM, better presentation
- Mac Murray Gayle presentation was impressive but CDM more experience
- Jim Fitch same as Keith, Brian CDM

- Study quote \$24,500

Parcel behind the High School

- Worth looking into options to acquire land
- Approx 3.1 acres.
- Committee members will look to see who owns that land, and propose a potential land donation for redesign

Ongoing plans and areas to investigate

- Town meeting will be an ask for funding for the project, and this committee will dissolve and a new committee will be formed
- Telegram Gazette grant for open fields. Hopedale must have an updated Open Field plan

- Hopedale is part of the Blackstone Valley National Park group. Potential grant money available thru govt
- Brian Murray potential state funding contribution
- Discussed grants to explore and other funding options. One thing Mike B. brought up was a debt exclusion for funding of fields. There was an article that he shared with the Committee. Northbridge is planning for a \$2.78M field's project that they are proposing to pay for with a debt exclusion, a temporary tax raise for them of \$570 for 1 year. A debt exclusion requires a 2/3 vote of the selectman and a ballot vote to pass.
