ARTICLE 1 - Approved unanimously at Special Town Meeting -11/29/2023 BANCROFT MEMORIAL LIBRARY HVAC SYSTEMS REPAIR/REPLACEMENT (Select Board) To see if the Town will vote to raise and appropriate or transfer from available funds a sum of money for design, engineering and all other costs associated with repairs and/or replacement of the heating and air conditioning systems at the Bancroft Memorial Library, or take any other action related thereto.

MOTION: Move that the Town vote to transfer the sum of \$101,000 from those funds as appropriated under Article 2 of the May 16, 2023 Annual Town Meeting; \$96,506 of said sum to be transferred from those funds appropriated under account 100 – General Government with the balance of \$4,494 to be transferred from account 400 – Public Works, the total being transferred to account 610 – Library as voted under Article 2 of said Annual Town Meeting to be utilized for design, engineering and all other costs associated with repairs and/or replacement of the heating and air conditioning systems at the Bancroft Memorial Library.
