# **ART ARTICLE 8**

## FISCAL YEAR 2025 COMMUNITY PRESERVATION COMMITTEE BUDGET

## (Community Preservation Committee)

To see if the Town will, upon recommendation of the Community Preservation Committee, appropriate from the Community Preservation Act fund, in accordance with M.G.L. c. 44B, such sums of money as it determines necessary for the expenses and charges for operation of the Community Preservation Committee for Fiscal Year 2025, or take any action related thereto.

**MOTION:** Move that the Town appropriate from the Community Preservation Act fund, in accordance with M.G.L. c. 44B, the sum of **\$8,500** for the expenses and charges for operation of the Community Preservation Committee for Fiscal Year 2025.

**<u>COMMENTARY</u>**: The approval of this article provides annual funding for the Community Preservation Committee's administrative and operational expenses. Under the Community Preservation Act, up to 5% of the ensuing fiscal year's estimated CPA revenues may expended for such purposes. By law, any balance remaining in this account at the end of the fiscal year is returned to the Community Preservation Act fund.

The Finance Committee recommends favorable action.

# **ARTICLE 9**

# COMMUNITY PRESERVATION COMMITTEE RESERVES

## (Community Preservation Committee)

To see if the Town will vote, upon recommendation of the Community Preservation Committee, to appropriate from the Community Preservation Act Fund, a sum of money pursuant to the requirements of the Community Preservation Act M.G.L. c. 44B, §6 for the purposes of Open Space, Community Housing (Affordable) and Historic Resources (Preservation), or take any other action related thereto.

**MOTION:** Move that the Town vote, pursuant to the requirements of the Community Preservation Act M.G.L. c.44B, §6, to appropriate from the Community Preservation Act Fund, as follows:

Reserve for Open Space\$17,000Reserve for Community Housing\$17,000Reserve for Historic Resources\$17,000

**<u>COMMENTARY</u>**: The purpose of this article is to comply with the provisions of M.G.L., Chapter 44B, §6, which requires that every fiscal year, upon recommendation of the Community Preservation Committee, Town Meeting shall spend, or set aside for later spending, not less than 10% of the estimated annual revenues in the Community Preservation Act Fund for each of the allowable purposes.

The Finance Committee recommends favorable action.
