Annual Town Election May 9, 2023 Hopedale, Massachusetts

In accordance with the posted warrant, for Annual Town Election, the inhabitants of the Town of Hopedale, qualified to vote in elections met in the Draper Gymnasium at 7:00 am with Warden Ellen Murphy in charge of the election.

At 8:00 pm the polls were closed. The number of ballots agreed with the checklist, and it was announced that the number of ballots cast was eight hundred seventy (870) which was 20.65%. At the time of the election there were four thousand two hundred thirteen (4213) inhabitants registered to vote.

The early voting ballots were processed during the polling hours. There were thirty- nine (39) vote by mail applications and thirty (30) were returned. Eight hundred forty (840) residents voted at the polls on election day.
