ANNUAL TOWN ELECTION MAY 8, 20817 HOPEDALE, MASSACHUSETTS

In accordance with the posted warrant for the Annual Town Election, the inhabitants of the Town of Hopedale, qualified to vote in elections met in the Draper Gymnasium at 7:00 AM with Warden Ellen Murphy in charge of the election.

At 8:00 PM the polls were closed and the ballots were sorted and counted. The number of ballots agreed with the checklist and it was announced that the number of ballots cast was one hundred seventy-four (174) which was 4.4%. At the time of the election there were three thousand nine hundred sixty-nine (3,969) inhabitants registered to vote.
